

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.mybetterlivingllc.com](http://www.mybetterlivingllc.com), and My Better Living, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to My Better Living, LLC include [www.mybetterlivingllc.com](http://www.mybetterlivingllc.com) and [www..](http://www..) The My Better Living, LLC application is a Health, Wellness Information & Ecommerce application. By using the My Better Living, LLC application, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, My Better Living, LLC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase My Better Living, LLC's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

## Use of your Personal Information

## Sharing Information with Third Parties

### **Right to Deletion**

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

### **Children Under Thirteen**

My Better Living, LLC does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this application.

### **E-mail Communications**
